. The DI Pipes shall conform to IS 8239/2000 with latest amendments and Pipes should have ISI mark

(c) Type Test Certificate for jointing shall be furnished for leak tightness of the joint design as per ISO.2531, cl no 7

(d) The DI manufacturer shall be required to furnish necessary Test Certificate from reputed Institution/Inspection Agencies towards establishment of "C" value of 140 for the pipe of diameter 300mm & above..

(e) Tenderer will have to produce valid income-tax, sales-tax, professional tax clearances certificate in original / certified copies (to be returned after verification) and submit one legible photo-copy of each including copy of credential along with the application for purchases of tender paper to HDA.
